

OVERVIEW

Terraced house to buy and renovate with splendid sea views, a private garden and a communal pool in Aiguafreda, Begur.

This terraced house is one of 24 houses in a gated community with a communal pool, tennis courts and controlled entry with a security service. It is located very close to the beach, just 5 minutes on foot from the idyllic Aiguafreda beach and 1 km from Sa Tuna Beach; 2 of the best beaches on the Costa Brava.

On the entrance level we find a guest toilet, utility room and a kitchen which is semi open to the living room – dining room which, in turn, leads out to a terrace with fabulous open sea views. Stairs take us down to the lower ground floor which offers 2 double bedrooms, a complete bathroom with a bathtub and the master bedroom with an en-suite bathroom and access to the patio. The patio leads to a storage room in the basement. The house is south-facing with open sea views. The garden leads to the famous "Camino de Ronda", a coastal walkway that leads to the beach.

The house requires renovation and offers enormous potential for a family looking for a home or holiday property in idyllic surroundings, just a few steps away from the beach, in a safe and comfortable gated community.
