

OVERVIEW

Fully renovated, architect-designed landmark property in an exclusive residential area of the Maresme coast

Built in 1969 and completely renovated in 2017/18, this elegant mansion was designed by renowned Catalan architect Lluis Cantallops I Valeri and has featured in many architectural journals.

Sitting on a very large hillside plot of just under 6,000m² with beautiful mature gardens in the shade of established pines, the 750m2 house offers total peace and privacy but is also a short walk from Sant Andreu de Llavaneres town centre.

The hillside location offers lovely views across the countryside and the coast, while the landscaped gardens and pool area also provide a lush, picturesque outlook from the living areas and bedrooms.

A unique modular design with several interlinked units includes the main house, a separate guest apartment with staff accommodation. Rooms have high ceilings and are arranged around a central patio, which harnesses maximum natural light and provides a lovely outlook from just about every room.

The large swimming pool is surrounded by lawns for sunbathing and includes a chillout zone. A tennis court is on hand for added sporting fun, and a huge room overlooking the garden is ideal for conversion to a gym, spa, games room, home cinema or studio.

No expense has been spared in the renovation, and the house has a stunning designer kitchen with DeDietrich appliances, sleek bathrooms and wonderful open areas including a split-level living room with a feature central fireplace and large windows overlooking the garden.

This is a 'smart' property packed with features to make life easier and more comfortable, including full domotic home automation, hot/cold air conditioning and a large rainwater collection tank for natural garden irrigation. There is plenty of open parking and a 4-car garage.
