OVERVIEW

The building consists of 3 floors with 6 apartments in total. On the top floor are 2 duplex penthouses with high wood clad ceilings. Each apartment has a living room with large wooden windows with balcony and fireplace. The apartments on the ground floor offer a terrace of 25 sqm plus a balcony. There are also 3 double bedrooms with wardrobes, 2 bathrooms, a utility room and a single, large and bright kitchen with a breakfast area and access to the balcony. All rooms are exterior facing and offer panoramic views and sunlight throughout the day.

Each apartment has a parking space and a storage room on the ground floor of the building. The finishes are of high quality with the best materials and the floors are wooden, except in the bathrooms, kitchen and utility room, where you will find ceramic floors.

The building also has a lift.


