## Large country property situated in Canyelles, 10 minutes from Sitges with a separate guest apartment, a large garden and a swimming pool and tourist licence for 18 guests.

This well presented, large country home for sale, located in the Sitges hills, would make a perfect country residence or a small hotel with room for up to 18 guests.

We enter this property through large wooden gates from the street and a sweeping driveway which leads us to the front door. Large double wooden doors open up to the hallway with a guest toilet on the left and then the generous sized living / dining room with an open plan recently installed modern kitchen. The room has views out to the garden and pool as well as mountain views through large dual aspect windows. There is also a cosy wood burner for winter evenings.

To the right of the hallway, we find 2 large double bedrooms overlooking the garden and the master suite with its recently refurbished bathroom with double sinks and a roll top bath.

Stairs from the living room lead up to the first floor which houses two further large double bedrooms and two bathrooms. There is also a large communal space here currently being used as a sitting room but could easily house a further two double bedrooms. This room leads out onto a large balcony.

On the lower ground floor we find another separate living area with a brand new large modern kitchen as well as a wine celler. This room has direct access to the garden. There is also a large garage for up to 3 cars on this level.

The exterior space is on three levels with the large heated pool with a cover for the colder months, terraces and garden from which to enjoy the stunning mountain views. On the lower level we find an independent guest apartment in a wooden house.

The interior of this property, with its recently refurbished kitchens and bathrooms, has been designed in a classical style with marble flooring and many decorative wooden details and quality materials.


