

In the prestigious Punta Brava development, one of the most exclusive enclaves in Sant Feliu de Guíxols, are these two magnificent detached designer villas, sold together. They boast a total of 721 m² of built area on plots surrounded by nature, offering privacy and unparalleled panoramic views of the Mediterranean Sea.

Punta Brava is located just minutes from the city centre, the marina, and the most spectacular coves on the Costa Brava. This residential area enjoys a privileged natural setting and excellent connections to Girona, Barcelona, and their airports.

The first house offers 326 m² of built area on a 1,350 m² plot and is spread over three floors connected by stairs and with elevator installation. The main floor houses an open-plan living room with large windows that open onto the terrace and the infinity pool with sea views. The separate kitchen is fully equipped with high-end appliances and includes a practical laundry area. It also has a guest toilet.

On the upper floor are three double bedrooms. The main bedroom has a dressing room and a private bathroom with a Jacuzzi and shower, while the other two share a contemporary bathroom.

The floor includes a garage for two large vehicles, an additional bedroom, and a full bathroom, ideal as a guest or service space.

The second villa, also built in 2015 and renovated in 2025, offers 395 m² spread over three levels with an elevator. The main floor features a bright living room surrounded by floor-to-ceiling windows that connect to the terrace and a spectacular infinity pool with sea views. It features a separate kitchen, a laundry area, and a guest toilet.

On the first floor, with high wood-paneled ceilings, there are three double bedrooms. The master suite features a dressing room and a full bathroom with a Jacuzzi and shower. The other two bedrooms share a modern, fully equipped bathroom.


In the basement, the property features a garage with capacity for two vehicles, an additional bedroom, and a full bathroom.
