

OVERVIEW

This well located villa boasts spectacular sea views from virtually every room. The quality interiors are in excellent condition with cherry wood carpentry and marble floors throughout. The generous sized double bedrooms each with their own private bathroom also offer fitted wardrobes and beautiful views.

We enter this property through the welcoming hallway on the ground floor where we also find a storage / utility room with a toilet as well as the large garage. There is also further exterior parking space in the courtyard in front of the garage.

The lift or stairs takes us up to the first floor with its 3 double bedrooms, 2 of which benefit from beautiful sea views. One of these bedrooms is currently being used as a study. On the second floor we find the living area which is connected to the seperate fully equipped kitchen with Balay appliances. For those who prefer an open kitchen it would be very easy to open up this space by removing the partition wall.

The living area opens up to a very spacious terrace, perfect for al fresco dining whilst looking out at the splendid view to the sea. This area also boasts a solid wooden pergola with a removeable awning, ideal for the hotter months.

Moving up to the third floor we find two more double bedrooms with ensuite bathrooms, both with access to the spacious wrap around terrace.

On the last floor we find the garden with astro turf lawn and swimming pool. Again on this level is a large wrap around terrace on which to enjoy the splendid scenery. Behind the pool the garden is elevated and borders the beautiful Garraf Natural Park. It would be possible to landscape this area if the new owners would like more outdoor space.
