This impressive maritime villa with a private pool and garden, just a few steps from the centre of Sitges, has been decorated with exceptional quality finishes, resulting in light and airy interiors. Distributed over 4 floors, a large group or a multigenerational family can be comfortably accommodated and enjoy access to the numerous terraces and outdoor spaces for recreational purposes.

The ground floor has a spacious and bright interior living room with a large sofa and access to a terrace with furniture for relaxation; just open the sliding doors and you will have the perfect indoor/outdoor living space. The large dining room, with space for a table seating 14 people, is a beautiful, airy space which overlooks the pool area. The kitchen has its own dining terrace overlooking the garden, with high-end Imperial appliances and all modern conveniences.

A lift to the second and third floor will take you to the 6 main bedrooms of the villa and then to the attic with its double bedroom under the eaves and boasting fantastic sea views. In total, there are 6 double rooms and a master suite in this villa. The wonderful master bedroom deserves a special mention, located on the first floor, sharing this level with another bedroom, with a twin walk-in wardrobe, large bathroom with a jacuzzi and separate shower. It also has a private terrace with a lovely view of the seafront promenade and the sea.
