Authentic 14th-Century country house in Canyelles; Ideal as a private residence full of history, space, and natural surroundings. Also suitable for cultural projects or tourist investment.

Lucas Fox is pleased to present this exceptional listed masia, an architectural gem with over six centuries of history, located in the peaceful and charming town of Canyelles, in the heart of the Garraf region. Just 15 minutes from Sitges and 45 minutes from Barcelona, this property offers a unique combination of heritage, natural surroundings, and multiple potential uses.

Built in the 14th century and last renovated in 2010, the masia is part of the Inventory of Architectural Heritage of Catalonia, ensuring both its cultural value and urban planning protection. The impressive main façade features a semicircular arched doorway with stone voussoirs, as well as an original Gothic twin-arched window adorned with carved vine motifs, a nod to the area's rich wine-making tradition.

The property consists of a large main building, several annexes, and a private garden of 210 m². The total built area is approximately 584 m², distributed over two floors:

On the ground floor, the home offers a large entrance hall, dining room, traditional kitchen with fireplace, guest toilet, one bedroom, and an interior courtyard with a well. From here, there is access to the garden, perfect for creating a charming outdoor space. A large storage room is also included, historically used for wine production and storage.

The first floor includes nine bedrooms (one of them en-suite with private bathroom), a guest toilet, a living room with a balcony, and a cosy reading or sitting room. This level also provides access to a 16 m² terrace with open views of the natural surroundings. In addition, there is a second 36 m² storage room with access only from the ground floor.

While the property is habitable, it does require some renovation and updating in order to restore its full original splendour and bring it in line with modern standards, an excellent opportunity to tailor the space to your vision.


