The owner has designed a project for this estate aimed at lovers of nature, sport horse breeding and equestrian competition, obtaining the necessary permits from the different administrations for the development of 140 hectares of surface in three different areas that provide a unique opportunity to create an unbeatable complex.

Surrounded by golf courses, hunting and culture, it is strategically located on the route of the most prestigious international equestrian clubs. From Oliva Nova with the MET, passing through Marbella, Estepona, Sotogrande, Montenmedio, Arcos de la Frontera (our project), Seville and Villamoura.

Since the beginning of this project, the natural treasures of the environment and the riches that the earth offers have been respected and conserved.

Both the guidelines for the design of buildings as well as those for green areas and road construction are detailed in the planning conditions to ensure that architectural and environmental standards are respected at all times.

The project was planned in this way: 90 hectares of residential area, 41 hectares of sports area and 9 hectares of hotel area.

The residential area is made up of 6 farms of 15 hectares each, where the owner can develop his agricultural business and build a 500 m² Andalusian farmhouse.
