Outstanding restored historic country house for sale 30 minutes from Santiago de Compostela and 3 km from beautiful beaches.

Located in the Rias Altas area of Galicia, in the village of Roo de Abaixo and just 30 minutes from Santiago de Compostela, we find this exceptional, fully renovated Classic Galicia Style Stone house for sale. The property is close to a large natural forest where you can find pretty streams and hiking trails. The location is idyllic; immersed in the countryside and enjoying stunning far-reaching views, yet just 5 minutes by car from local amenities and 3 km from gorgeous beaches, Rîa de Muros & Noia, which has over 60 white-sanded beaches along its way.

The home is located on an elevated, south-east facing plot comprising a wonderful 1,700 m² garden with a pool, an outdoor dining and entertaining area, a parking area and many charming spots to enjoy time with family and friends.

The house dates back to the early 1900s and was fully refurbished and designed with painstaking attention to detail by the current owner in 2007; satisfying all current requirements and with eco-friendly features.

On entering the home, we find the reception area and the games room. Towards the left we have the grand living and dining room with ceilings that are almost 5 metres high, exposed stone walls and beautiful high-end finishes. A fully equipped kitchen with a breakfast bar completes the area. Two double bedrooms and a large bathroom are found along the hall and a utility room and guest toilet are also located on the ground floor.

On the first floor we find a fantastic walk-through mezzanine area that overlooks the ground floor and leads to another sleeping area. Here we find 2 double bedrooms and an elegant complete bathroom.

With a wood burning fireplace, underfloor heating throughout the whole house and good quality double glazing windows and doors, the property has achieved a C rating for energy efficiency.

This property would make a superb holiday home or a sound investment as it has a rental licence for tourists and holidaymakers generating a good rental yield, being an established business at the highest end of the rental market. Furthermore, summers are usually fully booked and it outperforms the competition year after year.
